Total School Balances

The total school balances carried forward into 2020/21 are **£111,517.60**. This can be broken down into revenue balances, capital balances and community focussed balances as detailed below.

Revenue Balances

The total revenue balances (**B02**) carried forward into 2019/20 are **£83,688.60**. This represents **10.01%** of the total school revenue budget for 2019/20.
